PHOTOGRAPHY AND VIDEO CONSENT FORM

This form is to be signed by the Legal Guardian of a Child or Young Person under the age of 18, together with the Child or Young Person if over the age of 12.

Kent Cricket Board (KCB) will endeavour to inform you and all our young Cricketers if a photographer or the media will be at an event, recognising though that often we are not informed until it happens. If we publish any photographs ourselves, then we will not publish at the same time the names of any of the players in the photograph.

We will not knowingly permit photographs, video or other images of the young People who play Cricket with Kent Cricket Board to be taken without consent. If you feel photos or video are being taken without that consent, please advise the Coach or administrator immediately.

In order to be clear about what photography and video is allowed by you, and for KCB to keep to those wishes, we need you to complete this form and return it to us. Please note we will need Consent Forms for all individuals under the age of 18.

KCB is often asked by other cricketing organisations, particularly Kent County Cricket Club and the England and Wales Cricket Board, to use photos that we have published on our website. We have explained, as best we can, your rights over the further use of those photographs here on our website <http://www.kentcricketboard.co.uk/use-of-photographs/>

KCB will follow the guidance for the use of images of Young People, as detailed within the ECB Welfare of Young People Policy known as "Safe Hands", a copy of which is available on the Kent Cricket Board's website.

Kent Cricket Board will take steps to ensure these images are used solely for the purposes they are intended, which is the promotion and celebration of the activities of Kent Cricket Board.

If you become aware that these images are being used inappropriately, you should inform Dave Nash, County Welfare Officer immediately, via the KCB office. The information will be available on the KCB website or on <http://www.Play-Cricket.com>

If at any time either the Parent/Carer or the Young Person wishes the data to be removed from the website, 7 days' notice must be given to the County Welfare Officer after which the data will be removed.

All information will be handled in a secure and confidential manner and held in accordance with the 1992 Data Protection Act.
